RACE RULES AND REGULATIONS

I. ORGANIZER:

The Organizer of the Running Festival under the name "RESO SUWAŁKI HALF MARATHON", hereinafter referred to as "the Race" is the **Sports and Recreation Centre in Suwałki**, ul. Wojska Polskiego 2, 16-400 Suwałki, www.osir.suwalki.pl; e-mail sekretariat@osir.suwalki.pl; tel.+48 87 566 32 82, fax 87 563 18 56 (hereinafter Organizer).

II. GENERAL SPONSOR

The principal partner of the Race is RESO Europa Service sp. z o.o. ul. Innowacyjna 1, 16-400 Suwałki, entered in the register of entrepreneurs of the National Court Register kept by the District Court under number 0000243724, NIP: 844-219-13-72

III. PROJECT AIMS:

RESO SUWAŁKI HALF MARATHON is a sports project designed for person interested in active recreation and competitive sports with the following objectives:

- popularization and promotion of running as the simplest form of physical activity;
- integration of sports community
- promotion of the Town of Suwałki.

IV. PLACE AND TIME

1. The running festival titled: **RESO SUWAŁKI HALF MARATHON** will be held in Suwałki on 01-03 July 2022
 - 01.07.2022 r. (5 kilometers) – 20:00
 - 02.07.2022 r. (21.1 kilometers) – 20:00
 - 03.07.2022 r. (Breakfast Run 3,5 kilometers) – 09:00
2. The starts and finishes are localized on Wojska Polskiego 2 street (Arkadia Lake).
3. The length of the race is: 5 km with each kilometre marked.
4. Runners should report at the start of a run at least 20 minutes before the start.
5. The Organiser reserves the right to change the date and/or location of the Race, but in such cases Entrants will be notified about the change via the Organizer's website (www.osir.suwalki.pl) and at www.online.datasport.pl (internet-based system of registration for running events) no later than 24 hours before the start of the Race. Any such change does not incur any liability on the part of the Organizer to participants.

V. TIME LIMITS AND CHECKS

- I. Entrants are required to finish the race below 45 minutes counted from the starter's shot.
- II. The runners who fail to reach the finish within the prescribed limit are obliged to stop running, leave the course and reach the finish line by the bus marked with the 'KONIEC BIEGU' ('END OF THE RACE') sign.
- III. The runners who decide to continue running after the time limit has passed, do so on their own responsibility, subject to road traffic regulations and the provisions of the Polish Civil Code.
- IV. The runners who reach the finish line by bus shall not be included in the final classification. The race results will include also additional information next to the participants' names: DNF (did not finish) or DNS (did not start) in case the participant did not appear on the startingline.



V. FEED STATIONS AND CHECKPOINTS

1. There will be timing checkpoints along the course. Course-cutting or skipping any of the checkpoints becomes subject to the penalty of disqualification.
2. Apart from the checkpoint with the electronic timer, there will be other checkpoints arranged along the course where referees will continuously monitor the progress of the competition. Any participant who has been found to have gained an unfair advantage (“cutting the course”) or other actions in breach of the provisions these Rules becomes subject to the penalty of disqualification (“DQ”).

VI. PARTICIPATION AND REGISTRATION

1. In order to take part in the Race, participants have to be at least 16 years of age as of 01 July 2022. Persons under 18 years of age can take part in the competition basing on the consent of their legal guardian submitted to the Race Office
2. Organizer allows participation of self-propelled wheelchairs. Hand-bike or rim-push types of wheelchairs are not allowed.
3. Applications for on-line registration shall be accepted until **23 June 2022**. Beyond that deadline, applications will be accepted, subject to availability, by the Race Office.
4. All participants of the Race are obliged to call at the Race Office for verification, the office will be open:
 - a) On 1 July at **Suwalki Arena, ul. Zarzecze 26**
 - b) On 2 July at **Suwalki Arena, ul. Zarzecze 26**
5. In order to take part in the Marathon, Entrants shall:
 - a) fill in the application form available on the website datasport.pl
 - b) accept their personal responsibility for their Participation in the race regarding the dangers and risks arising from the nature and length of the Race, which include risks of deterioration or loss of health or life, be in good health and without medical contraindications against participation in racing,
 - c) express in writing their consent to the processing of the Participant's personal data given in the application form and submitting a statement confirming Participant's good state of health allowing him/her to participate in the Race, as well as consent to the inclusion of personal data in the form of name, surname, sex, year of birth, nationality, and image on TV, radio, Internet and in printed media information releases, as well as to sending by the Organiser to the indicated e-mail address information and questionnaires concerning RESO Suwałki Half Marathon. The Participant's personal data may be transferred to entities cooperating with the Personal Data Administrator and the Organiser under the realization of the RESO Suwałki Half Marathon and activities related to it, on the basis of data processing agreement, in accordance with article 31 of the Personal Data Protection Act of August 29th 1997 (Journal of Laws of 2016, item 922, as amended),
 - d) sign a disclaimer confirming their names and any footage or photographs taken during their participation may be used free of charge. The Participant gives the Sports and Recreation Centre in Suwałki and its sponsors a non-exclusive, territorially and temporally unlimited license to use his/her recorded image in the following fields of exploitation:

1. recording and multiplication by any known technique and distribution in any form,
 2. making its originally recorded version or its copy available to sponsors and official partners for use in promoting the sponsor or official partner's participation in the RESO Suwałki Half Marathon
 3. entering into computer memory or a multimedia network,
 4. multiplication of the recorded image,
 5. public display, screening, broadcasting or rebroadcasting, and making available to the public in such a way that everyone can have access to it at a place and time of their choice,
 6. printing and publication in the press, on Internet sites, posters and billboards,
 7. broadcasting in TV and radio releases,
 8. publication of the Participant's image in the photos from the course of the Race (links to photos and video materials will be placed next to the Participant's name);
- e) agree to undergo verification at the Race Office
6. During verification, each participant has to produce a valid identity document with a photograph.
 7. There is a limit of 500 starter assignable numbers, the decisive factor in assigning the starting numbers is the order of payment of entry fees.
 8. During the verification, Entrants shall receive race packs, including a race bib with a timing chip secured by foam.
 9. Organizer cannot guarantee to supply a T-shirt in the size declared at registration.
 10. Race packs may be claimed by third parties only basing on a participant's written declaration (**Annex 2 to these Rules**). In addition, you should also present a signed Participant's health statement.
 11. The race bibs not collected at the Race Office will not be sent or made available at a later time.

VII. **FEES**

1. Each Participant shall cover the costs of the Entry Fee, which depending on the date of payment will be:

2. The Entry Fee should be paid using the on-line service at www.datasport.pl via the DOTPAY system within 14 days following the registration (27 June is the closing date of on-line registration) or at the desk of the Race Office (stationary registration).
3. If the entry fee is paid in an insufficient amount (e.g. as a result of exceeding the deadline for payment specified in these Rules), the Competitor is obliged to pay the difference up to the amount that he/she should have paid in accordance with the deadline for his/her last payment.

**PERSONS WHO DO NOT PAY THE ENTRY FEE FOR THEIR PARTICIPATION
WITHIN 14 DAYS FROM THE DATE OF REGISTRATION WILL BE REMOVED
FROM THE STARTING LIST**

6. The following persons shall be exempt from entry fees, provided they register by **30 April 2022**:
 - a) persons aged 65+
 - b) persons exempt from paying the fee by Organizer.
7. After filling in the registration form, the Entrant who is entitled to exemption from the entry fee is obliged to send the registration information to biegi@osir.suwalki.pl. Doing this is a prerequisite for exemption from payment of entry fee.
8. The Organiser shall verify the right of free entry in the Race during the distribution of race packs at the Race Office. If Entrant does not meet the criteria outlined at point 4 above, the entry fee of **PLN 100.00** shall apply.
9. If the Registration Fee is paid via the website, payment is possible only in the Polish national currency (Polish zloty, PLN). Transactions are handled by the Internet payment system Dotpay Sp. z o.o. based in Krakow, on the basis of separate regulations developed by Dotpay Sp. z o.o.
10. The date of fee payment is understood as the date and time of the money transfer to the Organiser's bank account or receipt of cash payment at the Race Office. The entry fees are non-refundable except in cases when the Race is cancelled due to reasons attributable to Organiser, or when the fee was paid after the deadline.

11. In case of payment methods that involve payment of a commission towards a bank or other intermediary agency, the total fee paid must include the said commission. If the fee is not paid, the Participant may not register for the event.
12. The organiser shall not be liable for any loss of a postal order or bank transfer due to the fault of the post office or bank.
13. It is possible to transfer your Race number to another participant who has not yet obtained a number. Organizer allows this to happen before the deadline of 12 June 2022 inclusive. Assignment of your entry fee to another person should be made by sending information about the transfer by writing to: biegi@osir.suwalki.pl

VIII. CLASSIFICATION

1. The RESO Suwałki Half Marathon shall use the following classification categories:
 - **General Classification I-III** (separate for men and women),
 - **The Fastest Resident of Suwałki I-III** (separate for men and women) entrants qualified in accordance with the data entered on the identity card or other official document,
 - **The Fastest Inhabitants of the Podlaskie Voivodeship I-III** (separate for men and women) entrants qualified in accordance with the data entered on the identity card or other official document – **only halfmarathon**
 - **Fastest Polish Man and Polish Woman** - entrants qualified in accordance with the data entered on the identity card or other official document - **only halfmarathon**
 - **Age group classification (only halfmarathon):**
 - a. K-20 (women) / M-20 (men) (born in 2002-1993)
 - b. K-30 / M-30 (born in 1992-1983)
 - c. K-40 / M-40 (born in 1982-1973)
 - d. K-50 / M-50 (born in 1972-1963)
 - e. K-60 / M-60 (born in 1962– 1953)
 - f. K-70 / M-70 (born in 1952 and older)
 - **The Fastest Team (only 5k)** - the team consists of at least 5 people
2. The classifications shall be based on electronic time measurement recorded using the chip attached to the bib. A pressure timing mats will be placed along the race course recording the times of participant's appearance at the measurement point. Lack of recording for a given runner crossing a measurement point will disqualify the runner.
3. All classifications will be carried out according to individual net times counted from the moment of crossing the starting line to the moment of crossing the finish line with the exception of the first 50 competitors crossing the finish line, who will be classified according to gross time counted from the starter's shot.



4. A competitor at the finish line without a start number and electronic timing chip will not be classified.

IX. PRIZES

1. An condition to collect a prize is to preserve the race bib worn during the competition until the prize-giving ceremony.
2. The financial awards won during the Race will be transferred only by bank transfer to the indicated bank account (prizes will not be paid in cash) within 14 days from the date of the Race. Money prize winners shall receive the prizes less the income tax, as they are subject to applicable tax laws.
3. Any claims concerning the final results should be forwarded by 06 July 2022 by writing to biegi@osir.suwalki.pl. The final and official results will be published no later than on 15 July 2022.
4. Protests concerning awarded places in the general classification should be submitted to the Chief Judge immediately before the award ceremony (15 minutes before the award ceremony at the latest).
5. **The Fastest Resident of Suwałki** award is based on the runners' place of residence. In the absence of information about the place of residence in an ID, the Civil Registry Office in Suwałki will verify the place of residence of the winners. Documents confirming their residence in Suwałki can be e.g. electricity bill, bank statement, tax bill etc. Each participant of the mentioned above runs is obliged to confirm his residence within 7 days from the completion of the Race at the Department of Sport, Recreation and Marketing, ul. Wojska Polskiego 2, Suwałki.
6. In the case new sponsors/partners join our event, the pool of financial awards as well as services available to Entrants will be increased.
7. All entrants who **complete the Race** before the obligatory cut-off time will receive a commemorative medal.

X. FINAL PROVISIONS

1. The participants of the "RESO Suwałki Half Marathon" are bound by the regulations of the Race Rules and Regulations.
2. For safety reasons, it is forbidden for Participants to use bicycles, roller skates, rollerblades, skateboards, etc. during the Race. It is also forbidden to bring to the course of the Race objects that may create risks for other Participants, including Nordic Walking poles. Participants are obliged to observe all applicable laws, in particular the rules of fair play and these Rules and Regulations.
3. **Clothes deposit** Competitors can deposit their belongings in a specially designated place. They can be collected from the deposit only on the basis of the start number. In case of losing the start number by the Competitor, the Organizer cannot be held responsible for the clothes' bag being taken by another person. Attention: persons depositing valuables and documents do so on their own responsibility, the Organizer cannot be held responsible for any loss.
4. Before and after the race the competitors will be able to use a changingrooms.
5. Each Entrant is obliged to fasten their bib/start number on the front of his/her vest/t-shirt. The numbers must not be bent, cropped or obscured. Passing the race bib/number to another person will result in disqualification of the participant.
6. The Organizer shall not accept any private food supplements from the Entrants except those belonging to the members of the ELITTE group.



7. Mobile emergency service will be available along the length of the course. There will be an additional medical aid station located at the finish. A runner must immediately discontinue a run if the medical emergency service orders him/her to do it for medical reasons.
8. Persons not wearing valid race bibs/numbers are not allowed to stay on the race course. Persons not wearing valid race bibs/numbers will be removed from the race course by the Race staff.
9. Participants shall respect public order, observe any instructions from the security personnel and respect other participants of the Race.
10. Organiser shall be entitled to remove from the area of the competition any persons who in any manner disturb public order, disturb the course of the Race or their behaviour breaches these Race Rules and Regulations.
11. The Organizer cannot be held liable for any items lost during the event.
12. The final interpretation of the provisions of these Race Rules and Regulations belongs to the Organizer and the Main Referee of the Race.

XI. GENERAL DISCLAIMER OF THE CENTRE FOR SPORTS AND RECREATION IN SUWAŁKI

Regarding collecting your personal data which will be necessary/indispensable for fulfilling the statutory tasks of the Sports and Recreation Center in Suwałki, proper performance of contracts, organization of events and performance of other tasks of the Sports and Recreation Center in Suwałki, pursuant to art. 13 para. 1 and par. 2 of Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (general regulation on protection data, further: GDPR), the Centre for Sports and Recreation in Suwałki would like to advise you that:

1. The Administrator of your personal data is the Sports and Recreation Center in Suwałki, with its registered office in Suwałki at ul. Wojska Polskiego 2, 16-400 Suwałki, represented by its Director Waldemar Borysewicz, e-mail: sekretariat@osir.suwalki.pl
2. The Controller of the personal data at the Sports and Recreation Center is Mr. Zenon Rytwiński, e-mail: iod@osir.suwalki.pl,
3. Your personal data will be processed for the purpose of:
 - a) performance of statutory tasks of the Sports and Recreation Center in Suwałki and other legal duties, including contractual Sports and Recreation Center in Suwałki (legal basis: Article 6 (1) (c) of the GDPR),
 - b) implementation of legally justified interests of the Sports and Recreation Center in Suwałki (legal basis: Article 6 paragraph 1 point f) of the GDPR), such as the execution of agreements concluded with third parties, including our partners and sponsors, direct marketing of our services and tasks, establishing, defending and pursuing claims, creating collations and analyzes (such as reporting, marketing research, etc.) in connection with the performance of our statutory tasks and legal obligations, including contractual ones.
4. Your personal data will be processed:
 - a) for the duration of statutory tasks of the Sports and Recreation Center in Suwałki and other legal obligations, including contractual ones and / or
 - b) for the duration required by applicable laws concerning storage of data and / or



- c) for the duration of the time during which the Sports and Recreation Center in Suwałki may suffer legal consequences of improper performance or non-performance of its statutory tasks or legal obligations
5. Your personal data may be transferred by us to our partners with whom we have signed contracts for cooperation in the performance of our statutory tasks and other legal obligations, including contractual obligations, entities providing us with IT, legal assistance, advisory and consultancy services and other entities acting on our behalf and providing us with the services necessary to carry out our statutory tasks and performance of other legal obligations, including contractual obligations,
6. In compliance with GDPR, you have the right to:
 - a) demand access to personal information stored by us about you,
 - b) amend the said personal data,
 - c) request the removal or limit processing of your personal data
 - d) object to processing of your personal data
 - e) object to transfer of your personal data,
 - f) withdraw your consent to processing of your personal data at any time without affecting the legality of the processing which was carried out on the basis of consent before the withdrawal;
 - g) lodge a complaint to a supervisory body;
7. Submitting of your personal data by you is voluntary, but it may be a condition of your participation in our statutory tasks and therefore you will be required to provide it within the required by us limits whereas its lack may affect your participation in the implemented by us statutory tasks and our legal obligations, including contractual ones.
